Susan Silverstein





WEAVING TOGETHER THE PAST AND PRESENT

eidi Damsky of Birmingham is a talented knitter, a devoted grandmother, and a globetrotter, well-versed in the history of the Holocaust. All of these characteristics converged serendipitously when a friend of Mrs. Damsky's shared a pattern for a very special child's sweater. The pattern replicates a green sweater worn by Krystyna Chiger while hiding from the Nazis in the sewers of Lvov, Poland, from 1943 to 1944. Knitted by her beloved grandmother before the war, the sweater survived Krystyna's harrowing experience. Mrs. Damsky had just purchased yarn in the exact same shade of green to knit something for her granddaughter. She completed the sweater and decided to donate her beautiful replica of the green sweater to the Birmingham Holocaust Education Center's archives.

Krystyna Chiger and her family lived for fourteen months in the sewer with several other Jews, aided by Catholic sewer workers, who were able to provide meager rations. Conditions were extremely cramped and squalid, and the hidden families lived with the threats of rushing water, disease, rats, and of course the never-ending fear of being caught. All the while, the sweater gave young Krystyna a small amount of warmth and comfort throughout. Lvov was liberated by the Soviet Army in 1944, and the Chiger family moved to Krakow, and eventually to Israel. Krystyna later immigrated to the United States.

The original sweater is housed at the <u>United States</u> <u>Holocaust Memorial Museum</u>, where it remains in remarkably good condition considering its age, although it has rarely been displayed due to the fragility of textiles. However, in 2014, expert knitter, Dr. Lea Stern was moved by the story of the original and set out to create a pattern for knitters everywhere to keep the experiences of children in the Holocaust alive. Dr. Stern sought the approval of Krystyna Chiger, now known as Dr. Kristine Keren, for her project. The pattern is now sold at the USHMM gift shop, along with Dr. Keren's book, <u>The Girl in the Green Sweater</u>, published in 2008.


- Echoes and Reflections: Who Will Write Our History- A Special Conversation with Director Roberta Grossman; March 30



This month BHEC staff, along with educators from across the state and country, had the opportunity to participate in Facing History and Ourselves' "Holocaust & Human Behavior" teacher workshop. The seminar lasted four days and included large group sessions, breakout groups, and independent study time. The seminar helped to answer how studying the Holocaust allows students to wrestle with profound moral questions raised by this history and fosters their skills in ethical reasoning, critical thinking, empathy, and civic engagement- all of which are critical for sustaining democracy.
